Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the Fair Employment and Housing Council (Council) is providing notice of further changes made to section 11017 and proposed section 11017.1 of Title 2 of the California Code of Regulations covering the Fair Employment and Housing Act and Consideration of Criminal History in Employment Decisions.
