**THIRD NOTICE OF MODIFICATIONS TO TEXT OF HOUSING REGULATIONS REGARDING

Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the Fair Employment and Housing Council (Council) is providing notice of further changes made to sections 11098.1-11098.6 and 11098.23-11098.31 (renumbered to 12000-12070) of Title 2 of the California Code of Regulations covering the Fair Employment and Housing Act. These further changes are attached and made in response to written comments regarding the proposed regulations received during the second 15-day public comment period that ended August 4, 2017. Text proposed to be added for the third 15-day comment period is displayed in bold type. Text proposed to be deleted for the third 15-day comment period is displayed in italic type.
